WHEREAS, the Department approved the budget of Seven Hundred Eighty-Two Thousand Three Hundred Eighty-Four Pesos & 14/100 Only (P 782,384.14) for the Procurement of Supply and Delivery of Various Office Supplies (Not Available in DBM-PS) for NPS Region V;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the submission and opening of bids was scheduled on 15 September 2021;

WHEREAS, request for quotations from contractors/suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;


WHEREAS, that on the basis of the quotation given and after judicious evaluation, no bid was eligible for the said procurement activity;


