RECOMMENDING AWARD OF CONTRACT FOR THE OFFICE REPAIR, RENOVATION, AND MAINTENANCE OF PROVINCIAL PROSECUTION OFFICE OF CAMARINES NORTE, INCLUDING LABOR AND MATERIALS (RE-BIDDING) UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT, SECTION 53.9) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of Five Hundred Thousand Pesos Only (P 500,000.00) for the Office Repair, Renovation, and Maintenance of the Provincial Prosecution Office of Camarines Norte, including Labor and Materials;

WHEREAS, first Opening of Bids was scheduled on 19 July 2021, and was awarded to LJDB Construction;

WHEREAS, on a Verified Report submitted by the end-user, the procurement project has not yet commence and no progress despite the granted request for extension of delivery period, hence, causing inconvenience to the project site;

WHEREAS, in consideration of the foregoing, the BAC recommended termination of the contract under BAC Resolution No. 2021-10-029A, where the HoPE terminated the contract for the said procurement project on a letter to LJDB Construction dated 15 October 2021;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat re-posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, submission and opening of bids for re-bidding was scheduled on 28 October 2021;

WHEREAS, request for quotations from contractors/suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;


WHEREAS, per evaluation, bid of 417 LP Construction Corporation is found to be within the Approved Budget for the Contract (ABC), and is compliant with the scope of work and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.


NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the RPO V - BAC, hereby RECOMMEND to the Regional Prosecutor, the following:

1. **AWARD OF CONTRACT** via Small Value Procurement to 417 LP Construction Corporation for the Office Repair, Renovation, and Maintenance of Provincial Prosecution Office of Camarines Norte, including Labor and Materials, in the amount of Four Hundred Eighty Thousand Pesos Only (P 480,000.00), inclusive of appropriate taxes and fees.




