RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO ANGLOWEALTH ENTERPRISES FOR THE SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) UNIT COLLAPSIBLE TENT
