RESOLUTION

**RECOMMENDING THE AWARD OF CONTRACT TO

WHEREAS, Mr. Joseph H. Gregorio, Administrative Aide VI, National Prosecution Service, requested for the purchase of various consumables for copier machine model Ineo 287 for the official use of the Office of Senior Deputy State Prosecutor Miguel F. Gudio, Jr., to wit:

WHEREAS, the procurement of spare parts and consumables for various photocopying machines is included in the CY-2021 Annual Procurement Plan (APP) of the Department with an allotted budget of P2,940,604.70, with Direct Contracting as the mode of procurement;

WHEREAS, a letter of confirmation dated 1 April 2021 was issued by Konika Minolta Business Solutions Asia Pte Ltd, through its General Manager Yutaka Iwamoto, appointing Copylandia Office Systems Corporation (Copylandia) as their exclusive distributor for the sale and/or rental of the "DEVELOP" branded black and white, and color electrostatic plain paper copying/printing machines and their consumables and spare parts in the Philippines;

WHEREAS, Copylandia Office Systems Corporation submitted a quotation for the said consumable items for copier machine model Ineo 287 in the amount of Eleven Thousand Eight Hundred Four Pesos (₱ 11,804.00);


