**RESOLUTION DECLARING SECOND FAILURE OF BIDDING FOR THE  
PROCUREMENT OF JANITORIAL SERVICES FOR DOJ BUILDING – OPP  
CATANDUANES FROM SEPTEMBER - DECEMBER 2021; 2 UTILITY WORKERS;  
MONDAY TO SATURDAY; 8 HOURS PER DAY**

**WHEREAS**, the Department approved the budget of One Hundred Forty Thousand Pesos Only (P 140,000.00) for the Procurement of Janitorial Services for DOJ Building – OPP Catanduanes from September – December 2021; 2 Utility Workers; Monday to Saturday; 8 Hours per Day;

**WHEREAS**, during the scheduled first opening of bid on 03 September 2021, J2K Manpower and Allied Services was declared INELIGIBLE due to no bid offer and no submitted documentary requirements;

**WHEREAS**, the BAC declared First Failure of Bidding and recommended Re-bidding under BAC Resolution No. 2021-09-020;

**WHEREAS**, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat re-posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

**WHEREAS**, the submission and opening of bids for re-bidding was scheduled on 15 September 2021;


**WHEREAS**, request for quotations from contractors/suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

**WHEREAS**, that on the basis of the quotation given and after judicious evaluation, no bid was eligible for the said procurement activity;




