

RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO JT OFFICE SUPPLIES AND EQUIPMENT TRADING FOR THE PURCHASE OF COMMON OFFICE SUPPLIES AND EQUIPMENT

WHEREAS, there is a need for the Department of Justice (DOJ) to purchase sixteen (16) pieces of Common Office Supplies and Equipment for Region IV;

WHEREAS, the procurement of this project is included in the CY 2021 Annual Procurement Plan (APP) under negotiated procurement thru shopping with an approved budget **Four Hundred Forty One Thousand One Hundred Thirty One Pesos & 85/100. (Php 441,131.85)**

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project was reposted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for six (6) calendar days starting on 29 September 2021;

WHEREAS, in response to the said RFQ, four (4) prospective suppliers submitted their quotations, *to wit*:

WHEREAS, after review and evaluation, the Bids and Awards Committee - Technical Working Group (BAC-TWG) found **JT Office Supplies and Equipment Trading** to be legally, financially, and technically capable to undertake the subject procurement, having submitted the lowest, calculated, and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to negotiated procurement thru shopping, and

further recommend the award of contract to **JT Office Supplies and Equipment Trading**, in the amount of **FOUR HUNDRED THIRTY-NINE THOUSAND ONE HUNDRED SEVENTY-NINE PESOS (P439,179.00)**, for the purchase of common office supplies and equipment, following the procedures prescribed in R.A. 9184 and its Implementing Rules and Regulations.


