

RESOLUTION

RECOMMENDING THE AWARD OF CONTRAC TO FREDOWIL MEDICAL SUPPLIES FOR THE PURCHASE OF MEDICAL SUPPLIES AND INSTRUMENT FOR NPS-REGION IV

WHEREAS, there is a need for the Department of Justice (DOJ), to purchase four (4) items of medical supplies and laboratory instrument for the use of National Prosecution Services- Region IV (NPS-Region IV);

WHEREAS, the procurement of this project is included in the CY 2021 Annual Procurement Plan (APP) under negotiated procurement thru shopping with an approved budget *Two Hundred Ninety Six Thousand Four Hundred Fifty Seven Pesos & 20/100* (Php 296,457.20).

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for four (4) calendar days starting on 24 September 2021

WHEREAS, in response to the said RFQ, for six (6) prospective suppliers submitted their quotations, to wit;
