## **RESOLUTION**

### **A RESOLUTION RECOMMENDING THE APPROVAL OF PURCHASE ORDER NO. 03-2021 FOR THE PURCHASE OF SEMI-EXPENDABLE FURNITURES AND FIXTURES FOR THE USE OF THE REGIONAL, PROVINCIAL AND CITY PROSECUTION OFFICES, REGION VI.**

**WHEREAS**, there is an urgent need to purchase semi-expendable furnitures and fixtures for the use of the Regional, Provincial and City Prosecution Offices, Region VI;

**WHEREAS**, the purchase of the aforementioned goods is included in the Annual Procurement Plan (APP) for the CY 2021 of the Department Proper;

**WHEREAS**, the above-mentioned project has an approved budget for contract of Five Hundred Seventy Thousand Four Hundred Pesos (P 570,400.00);

**WHEREAS**, Regional Prosecution Office 6 through its Bids And Awards Committee (BAC), posted the request for Quotation for the above-mentioned project through posting in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and Iloilo City Government Office and Iloilo Provincial Capitol;

**WHEREAS**, the BAC also requested quotations from three (3) suppliers viz (1) Uni-Art Supply Inc., (2) Apstar Trader & Printers, (3) Iloilo Izeem Commercial;

**WHEREAS**, the submission and opening of bids was scheduled on August 16, 2021;

**WHEREAS**, as a result of the bid opening, Uni-Art Supply, Inc. was found to have the Lowest Calculated and Responsive Bid;

**WHEREAS**, considering that the amount involved in the subject procurement is Five Hundred Sixty-Six Thousand Eight Hundred Ten Pesos (**566,810.00**) an alternative mode of Negotiated Procurement (Small Value Procurement) under Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA No. 9184) may be resorted to.

**NOW, THEREFORE**, for and in consideration of the foregoing, the Bids and Awards Committee resolves, as it hereby RESOLVES, to recommend the APPROVAL of the alternative method of Negotiated Procurement (Small Value Procurement) under Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA No. 9184), and further recommends the approval of Purchase Order No. 03-2021 dated August 16, 2021, in the amount of Five Hundred Sixty Six Thousand Eight Hundred Ten Pesos (**566,810.00**).
