## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT TO PHILIPPINE DAILY INQUIRER FOR THE PUBLICATION OF NAMES OF PERSONS DEPRIVED OF LIBERTY BEING CONSIDERED FOR EXECUTIVE CLEMENCY**

**WHEREAS**, there is a need for the publication of the names of Persons Deprived of Liberty (PDL) being considered for Executive Clemency in a newspaper of general circulation;

**WHEREAS**, the said publication of names of PDL being considered for Executive Clemency is included in the CY 2021 Annual Procurement Plan (APP) under negotiated procurement with an allotted budget of Three Hundred Sixty Thousand Pesos (P 360,000.00);

**WHEREAS**, in a letter request dated 22 February 2021, Executive Director Reynaldo G. Bayang, Board of Pardons and Parole (BPP), stated that the publication is a requirement in processing Executive Clemency cases with an approved date of October 19, 2020 and November 25, 2020;

**WHEREAS**, pursuant to the rules on *Negotiated Procurement-Procedures for Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services*<sup>1</sup>, the BPP conducted a market study wherein the following entities submitted quotations for the said publication, namely: Philippine Daily Inquirer, Manila Standard, and Manila Bulletin;

**WHEREAS**, the result of the proposals submitted as shown in the abstract of quotation, are as follows:
