## **RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO FORTUNE GATE CORPORATION FOR THE LUNCH AND P.M. SNACKS OF DOJ EMPLOYEES AND TO ROXAS FOOD VENTURES, INC. (THE ARISTOCRAT RESTAURANT) FOR CATERING SERVICES IN CONNECTION WITH THE 124<sup>TH</sup> FOUNDING ANNIVERSARY OF THE DEPARTMENT OF JUSTICE**

**WHEREAS**, there is a need to procure the catering services, packed lunch and pm snacks in connection with the 124<sup>th</sup> founding anniversary of the Department of Justice (DOJ);

**WHEREAS**, the procurement of this project is included in the CY 2021 Annual Procurement Plan (APP), with an approved budget of Three Hundred Thirty Thousand Pesos (₱ 330,000.00);

**WHEREAS**, the Request for Quotation (RFQ) for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for six (6) calendar days;

**WHEREAS**, in response to the said RFQ, two (2) prospective suppliers submitted their quotations, *to wit*:

(The Aristocrat Restaurant) for the catering services for the guests of the DOJ Secretary because aside from good tasting and reasonably priced food, it includes tables & chairs (with cover), ceramic plates, silver ware, and waiters in uniform;

**WHEREAS**, the Bids and Awards Committee - Technical Working Group, after review, evaluation, and in consideration of the recommendation of the 2021 DOJ Founding Anniversary Committee, found Fortune Gate Corporation and Roxas Food Ventures, Inc. (The Aristocrat Restaurant) to be legally, financially, and technically capable to undertake the subject procurement;



(THE ARISTOCRAT RESTAURANT)** for the catering services of guests of DOJ Secretary – lunch & pm snacks in the amount of **TWENTY-FIVE THOUSAND PESOS (₱ 25,000.00)**, in connection with the 124<sup>th</sup> founding anniversary of the Department, following the procedures prescribed in R.A. 9184 and its Implementing Rules and Regulations.
