RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PHILCOPY CORPORATION FOR THE PURCHASE OF CONSUMABLE ITEMS AND VARIOUS SPARE PARTS FOR KYOCERA MULTIFUNCTION LASER COPIER TASKALFA 2200

WHEREAS, Ms. Patricia Josefina R. Buenafe, Senior Administrative Assistant I, National Prosecution Service (NPS), requested for the purchase of consumable items and various spare parts for Kyocera multifunction laser copier Taskalfa 2200 for official use by the Office of Senior Deputy State Prosecutor Mariza D. Jaugan., to wit:

WHEREAS, the procurement for various spare parts for photocopying machines of NPS is included in the CY-2021 Annual Procurement Plan (APP) of the Department, with an allotted budget of ₱ 200,000.00, with Direct Contracting as the mode of procurement;


WHEREAS, a Sworn Certificate of Guarantee Exclusive Distributorship Agreement dated 12 March 2021 was issued by Kyocera Document Solutions Asia Limited through its President Takuma Kimura appointing Philcopy Corporation as their exclusive distributor in marketing and servicing Kyocera Document Solutions brand multi-functional products, laser printers and multi-functions peripheral, software solutions, including related consumables and spare parts in the Philippines;

WHEREAS, Philcopy Corporation submitted a quotation for the said consumable items and spare parts for Kyocera multifunction laser copier Taskalfa 2200 in the amount of Thirty-Two Thousand One Hundred One Pesos (₱ 32,101.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to alternative mode of procurement of Direct Contracting, and further recommend the award of contract for the purchase of consumable item and various spare parts for Kyocera multifunction laser copier Taskalfa 2200 to **Philcopy Corporation**, exclusive distributor of Kyocera Document Solutions Asia Limited, in the amount of **THIRTY-TWO THOUSAND ONE HUNDRED ONE PESOS (₱ 32,101.00)**, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
