RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO VIGILANT INVESTIGATIVE AND SECURITY AGENCY, INC. FOR THE PROCUREMENT OF SECURITY SERVICES FOR FY 2022

WHEREAS, there is a need to procure security services for FY 2022 as part of the early procurement activities of the Department of Justice (DOJ);

WHEREAS, this project is included in the CY-2022 Indicative Annual Procurement Plan with an allotted budget of Nineteen Million Five Hundred Sixty Thousand Thirty-Four Pesos & 40/100 (₱ 19,560,034.40);

WHEREAS, the Invitation to Bid (ITB) for the aforementioned project was posted in the DOJ and PhilGEPS website, and in conspicuous place in the DOJ starting 02 November 2021 with an approved budget for the contract of Ten Million Six Hundred Fifteen Thousand Three Hundred Sixty-Two Pesos & 84/100 (₱ 10,615,362.84);

WHEREAS, in the pre-bidding conference held on 9 November 2021, only one (1) prospective bidder, Vigilant Investigative and Security Agency, Inc., participated;

WHEREAS, only one (1) bidder, Vigilant Investigative and Security Agency, Inc., bought bid documents and submitted its bid which was opened on 23 November 2020, 11:00 a.m. *via google meet, to wit:*


