RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO SURE TIRE TRADING FOR THE SUPPLY AND INSTALLATION OF TIRES FOR VARIOUS OFFICIAL VEHICLES OF THE DEPARTMENT OF JUSTICE

WHEREAS, there is a need for the Department of Justice (DOJ) to procure the supply and installation of tires for various official vehicles of the Department;

WHEREAS, the procurement of this project is included in the CY-2021 Annual Procurement Plan (APP), under negotiated procurement with an allotted budget of Six Hundred Eighty Seven Thousand Seven Hundred Fifty-Five Pesos (₱ 687,755.00);

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for six (6) calendar days;

WHEREAS, in response to the said RFQ, two (2) prospective suppliers submitted their quotations, to wit,


