RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO EXIST CORPORATION FOR THE SUPPLY AND INSTALLATION OF OPERABLE SOUND-PROOF PARTITION WALLS

WHEREAS, there is a need to procure operable sound-proof partition walls for the multi-purpose hall at the Delas Alas Building in the Department of Justice (DOJ);

WHEREAS, the procurement of this project is included in CY 2021 Supplemental Annual Procurement Plan No. 1 (SAPP 1) with an Approved Budget for the Contract of Three Million Pesos (₱ 3,000,000.00);

WHEREAS, the Invitation to Bid (ITB) for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department starting 25 May 2021;

WHEREAS, in response to the said ITB, one (1) prospective bidder submitted its bid during the bidding conference evaluation held *via* google meet on 15 June 2021, at 10:00 a.m, to wit:

WHEREAS, the said bid was referred to the BAC-Technical Working Group (TWG) for evaluation and post-qualification, and noted the following findings:
