RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO NEONOTION EVENTS MANAGEMENT FOR THE COMPLETE LIGHTS AND SOUND SYSTEM, ARTIST/ENTERTAINERS/EMCEE, AND PRODUCTION ASSOCIATES FOR THE 2021 DEPARTMENT OF JUSTICE YEAR-END ASSESSMENT

WHEREAS, there is a need to procure the project: complete lights and sound system, artists/entertainers/emcee and production associates for the Department of Justice Christmas celebration on 17 December 2021, itemized as follows:

WHEREAS, the procurement of the said project is included in the CY-2021 Annual Procurement Plan (APP) lodged under Year-End Assessment (Meals: lunch, snacks, and dinner) and other incidental expenses with negotiated procurement as the mode of procurement and an allotted budget of One Million One Hundred Seventy Thousand Pesos (₱ 1,170,000.00);

WHEREAS, the Request for Quotation (RFQ) with an approved budget for the contract of One Hundred Seventy Thousand Pesos (₱ 170,000.00) for the aforementioned project was sent to three (3) suppliers, namely: Neonotion Events Management, Sound Level Pro Lights and Sounds, and Music First Sounds & Lighting;

WHEREAS, in response to the said RFQ, a prospective supplier submitted its quotation, *to wit*:


