RESOLUTION DECLARING SECOND FAILURE OF BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF 14 UNITS GENERATOR SET FOR DOJ NPS REGION V UNDER COMPETITIVE BIDDING OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of Nine Hundred Eighty Thousand Pesos Only (P 980,000.00) for the Procurement of Supply, Delivery, Installation, Testing and Commissioning of 14 units Generator Set for DOJ NPS Region V;

WHEREAS, first Opening of Bids was scheduled on 27 October 2021, however, it was declared Failure of Bidding and recommended Re-Bidding with Re-Posting under BAC Resolution No. 2021-10-035;


WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat re-posted the Bidding Document in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the Submission and Opening of Bids was scheduled on 17 November 2021;


WHEREAS, no bid was received during the scheduled Opening of Bids;

NOW THEREFORE, We, the Members of the Bids and Awards Committee (BAC) RESOLVE as it is hereby RESOLVED to declare SECOND FAILURE OF BIDDING and to recommend conduct of RE-BIDDING WITH RE-POSTING for the Supply, Delivery, Installation, Testing and Commissioning of 14 units Generator Set for DOJ NPS Region V under Two Failed Biddings (Section 53.1) of the Revised IRR of RA 9184.






