WHEREAS, on the same date, the BAC evaluated the bid of Philcopy Corporation, together with the attached documentary requirements, specifically, Certified True Copy of Mayor's Permit, Certified True Copy of BIR Registration, Certified True Copy of SEC Registration, Certified True Copy of PhilGEPS Registration Number, and Certificate of Exclusive Distributorship;


WHEREAS, per evaluation, bid of Philcopy Corporation is found to be compliant with the specification and eligibility requirements;


