RECOMMENDING AWARD OF CONTRACT FOR THE PURCHASE AND DELIVERY OF CONSUMABLES FOR VARIOUS PRINTERS (NOT AVAILABLE IN THE PROCUREMENT SERVICE) FOR NPS REGION V UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT, SECTION 53.9) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of One Hundred Eighty-Eight Thousand Twenty-Eight Pesos Only (P 188,028.00) for the Purchase and Delivery of Consumables for Various Printers (Not Available in the Procurement Service) for NPS Region V;

WHEREAS, the Regional Prosecution Office V through the Bids and Awards Committee (BAC), posted the Request for Quotation (RFQ) for the above-mentioned project in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and in conspicuous place in the premises of Regional Prosecution Office V;

WHEREAS, on 14 May 2021, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above-mentioned project to the following suppliers, viz;

1. 3GX Computer & I.T. Solutions
2. Denver's Computer Shoppe, Inc.
3. Razorclaw Technologies and Solutions, OPC
4. Lucky Educational Supply
5. Legazpi Jebson Trading

WHEREAS, the submission and opening of bids was scheduled on May 20, 2021;

WHEREAS, in the course of the evaluation of the bids by the BAC the following are the result:


WHEREAS, per evaluation, the bid proposal of Legazpi Jebson Trading is found to be compliant with the technical specifications and eligibility requirements;
