**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 12 UNITS FIRE EXTINGUISHER, HCFC, COLOR GREEN, 10 LBS, DRY CHEMICAL FOR OPP CATANDUANES BUILDING UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT, SECTION 53.9) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.**

**WHEREAS**, the Department approved the budget of Ninety-Nine Thousand Pesos Only (P 99,000.00) for the Procurement of Supply and Delivery of 12 units Fire Extinguisher, HCFC, Green, 10 lbs, dry chemical for OPP Catanduanes Building;

**WHEREAS**, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

**WHEREAS**, the submission and opening of bids was scheduled on 02 August 2021;

**WHEREAS**, request for quotations from contractors/suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;


**WHEREAS**, per evaluation, bid of Ash Enterprises is found to be compliant with the specification and eligibility requirements;




