**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO
OHANNA'S MEDICAL SUPPLIES TRADING FOR THE PURCHASE OF

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), requested quotations for the purchase of disinfectant, liquid solution, concentrated with the Approved Budget for the Contract (ABC) of Thirty Seven Thousand, Six Hundred Sixty Five Pesos (Php 37,665.00);

WHEREAS, the BAC received three (3) quotations for the purchase of disinfectant, liquid solution, concentrated from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:

WHEREAS, ELYU SUPPLY ENTERPRISES OPC's offer was declared the 3rd LCRB;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the Lowest Calculated Responsive Bidder, the BAC found the offer of Ohana's Medical Supplies Trading to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of the contract;
