**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO
OHANNA'S MEDICAL SUPPLIES TRADING FOR THE PURCHASE OF
DISINFECTING FOOT BATH MAT WITH TRAY FOR NPS- REGION 1**

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), requested quotations for the purchase of disinfecting foot bath mat with tray with the Approved Budget for the Contract (ABC) of Five Thousand, Nine Hundred Seventy Five Pesos (Php 5,975.00);

WHEREAS, the BAC received three (3) quotations for the purchase of disinfecting foot bath with tray from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:

WHEREAS, as a result of bid opening, Ohana's Medical Supplies Trading's bid was declared the 1st Lowest Calculated and Responsive Bid (LCRB);

WHEREAS, R2MMM Pharma and Medical Supplies Trading's offer was declared the 2nd LCRB;


WHEREAS, ELYU SUPPLY ENTERPRISES OPC was disqualified as the bid exceeded the ABC;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the Lowest Calculated Responsive Bidder, the BAC found the offer of Ohana's Medical Supplies Trading to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of the contract;

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby **RESOLVED**, to recommend to the Head of the Procuring Entity the award and approval of Purchase Order No. 2021- 09- 015 in the amount of Five Thousand, Seven Hundred Eighty Pesos (Php 5,780.00) for the purchase of Disinfecting Foot Bath Mat with Tray for NPS- Region 1 in favor of Ohana's Medical Supplies Trading.


