**RESOLUTION NO. 2021-12-0021**

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO SAN JUAN BEACH RESORT DEVELOPMENT AND MANAGEMENT CORPORATION FOR THE CONDUCT OF GENDER AND DEVELOPMENT TRAINING (MEALS, VENUE AND ACCOMMODATION) ON DECEMBER 13-14, 2021 FOR NPS-REGION 1**

**WHEREAS**, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), posted the conduct of Gender and Development Training (Meals, Venue and Accommodation) with the Approved Budget for the Contract (ABC) of Three Hundred Thirty Thousand Pesos (Php 330,000.00) on November 30 - December 6, 2021 in the PhilGEPS, DOJ Website and in a conspicuous place in the premises of the City of San Fernando, La Union;

**WHEREAS**, the BAC received three (3) quotations for the conduct of Gender and Development Training (Meals, Venue and Accommodation) from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:

Calculated Bidder, the BAC found the offer of San Juan Beach Resort Development and Management Corporation to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of contract;
