INVITATION TO BID

The Department of Justice-National Prosecution Service Region 02 (DOJ-NPS), through the Bids and Awards Committee (BAC) is inviting interested parties to bid for the following project:

Procurement of Security Services for FY 2022

Approved Budget of the Contract: Php1,800,000.00
Delivery Period: one (1) year (from January 1, 2022- December 31, 2022)
Location: DOJ-NPS Regional Office 02, Dalan Na Angicacua,
Regional Government Center, Carig Sur, Tuguegarao City,
Cagayan

The prospective bidders must have an experience of having completed, within a period of five (5) years from the date of submission and receipt of bids, at least one (1) contract similar to the contract of the bid, and whose value, adjusted to current price using PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of the Revised Implementing Rules and Regulation (IRR) of Republic Act 9184 dated 28 October 2016 and GPPB Resolution No.09-2020, dated 7 May 2020.
