
1. Preferably a fiber optic internet connection;
2. Minimum of megabits per second (Mbps) as indicated;
3. Internet Service Provider (ISP) must include all the necessary network equipment / applicable / in-house cabling from internet provider facility to the end-user office and must be operational;
4. The service provider must have a 24/7 help desk support.

General Conditions:

1. All entries must be legibly written;
2. Suppliers must indicate only one quote per item, multiple quotations are grounds for disqualification from participating in the procurement at hand;
3. Quoted prices must be inclusive of taxes and other charges of fees and shall not exceed the Approved Budget for the Contract (ABC);
4. Bidders must indicate warranties, and other terms and condition when applicable.
