RESOLUTION TO RECOMMEND TO THE HEAD OF THE PROCURING ENTITY TO AWARD THE CONTRACT FOR THE PROCUREMENT OF 150 GALLONS ETHYL ALCOHOL (COVID-19 RESPONSE ITEM) IN ACCORDANCE WITH THE PROVISION OF SECTION 52.1b OF THE 2016 REVISED IRR OF RA 9184 (SHOPPING – ORDINARY/REGULAR OFFICE SUPPLIES & EQUIPMENT)

WHEREAS, the Bids and Awards Committee (BAC) of the Regional Prosecution Office, Region XI, resorted to Alternative Methods of Procurement in accordance with the provisions of Section 52.1b of 2016 revised IRR of RA 9184 (**Shopping – Ordinary/Regular Office Supplies & Equipment**) for the procurement of **150 gallons ethyl alcohol** (Covid-19 response item) not available in the Procurement Service Depot XI;

WHEREAS, the Head of Office approved the procurement of 150 gallons ethyl alcohol, an item not available in the Procurement Service Depot XI, from outside source;




