RESOLUTION

**RECOMMENDING THE AWARD OF CONTRACT TO
COPYLANDIA OFFICE SYSTEMS CORPORATION FOR
THE PURCHASE OF FUSING UNIT OF PHOTOCOPIER MODEL
DEVELOP INEO 287 FOR THE OFFICIAL USE OF THE PAYROLL /
APPOINTMENT SECTION OF THE DEPARTMENT OF JUSTICE**

WHEREAS, Ms. Celestina P. Miñas, Chief, Payroll Section of the Department, requested for the purchase of fusing unit of photocopier model DEVELOP INEO 287 for the official use of the payroll/appointment section of the Department, to wit:

WHEREAS, the procurement for spare parts and consumables for various photocopying machines is included in the CY-2021 Annual Procurement Plan (APP) of the Department with an allotted budget of Two Million Nine Hundred Forty Thousand Six Hundred Four Pesos and 70/100 (₱ 2,940,604.70) and Direct Contracting as the mode of procurement;

WHEREAS, a letter of confirmation dated 21 April 2021 was issued by Konika Minolta Business Solutions Asia Pte Ltd through its General Manager Yutaka Iwamoto confirming that Copylandia Office Systems Corporations (Copylandia) is their exclusive distributor for the sale and/or rental of the "DEVELOP" branded black and white, and color electrostatic plain paper copying/printing machines and their consumables and spare parts in the Philippines;

WHEREAS, Copylandia Office Systems Corporation submitted a quotation for the said consumable item for photocopier model DEVELOP INEO 287 in the amount of Fourteen Thousand Seven Hundred Twenty Pesos (₱ 14,720.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to alternative mode of

procurement of Direct Contracting, and further recommend the award of contract for the purchase of fusing unit of photocopier model DEVELOP INEO 287 for the official use of the payroll/appointment section of the Department in the amount of **FOURTEEN THOUSAND SEVEN HUNDRED TWENTY PESOS (₱ 14,720.00)**, to **Copylandia Office Systems Corporation**, as exclusive distributor of Konika Minolta Business Solutions Asia Pte Ltd, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.


