## **RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO ROXAS FOOD VENTURES, INC. (ARISTOCRAT RESTAURANT) FOR THE PURCHASE OF PACKED MEALS FOR THE INAUGURATION OF THE FIRST INTER-AGENCY COUNCIL AGAINST TRAFFICKING CYBER-TAHANAN NG INYONG PAG-ASA MONITORING TO BE HELD IN MANDALUYONG CITY ON 22 JULY 2021**


