RESOLUTION

**RECOMMENDING THE AWARD OF CONTRACT TO
RED ROOT ARTISTS AND ARTISANS MULTI-PURPOSE COOPERATIVE
FOR THE VIDEO PRODUCTION OF THE VIRTUAL LAUNCHING OF THE
INTER-AGENCY COUNCIL AGAINST TRAFFICKING'S
KNOWLEDGE PRODUCTS**

WHEREAS, there is a need of a video production for the virtual launching of the Inter-Agency Council Against Trafficking's (IACAT) knowledge products;

WHEREAS, the procurement of the said video production is included in the DOJ CY 2021 Annual Procurement Plan (APP) with an allotted budget of Five Hundred Thousand Pesos (₱ 500,000.00);

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project was posted on 23 June 2021 in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for six (6) calendar days;

WHEREAS, in response to the said RFQ, three (3) prospective suppliers submitted their quotations, to wit,

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to negotiated procurement thru Small Value Procurement, and further recommend the award of contract for the video production of the virtual launching of IACAT's knowledge products to **RED ROOT ARTISTS AND ARTISANS MULTI-PURPOSE COOPERATIVE** in the amount of **THREE HUNDRED SEVENTY THOUSAND PESOS (P 370,000.00)**, following the procedures prescribed in R.A. No. 9184 and its Implementing Rules and Regulations


