RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO E-COPY CORPORATION FOR THE PURCHASE OF VARIOUS CONSUMABLES FOR SHARP AR 6031N COPIER MACHINE FOR THE OFFICIAL USE OF THE RECORDS MANAGEMENT SECTION OF THE DEPARTMENT OF JUSTICE

WHEREAS, Mr. Arnold Paul D. Abes, Administrative Aide IV, Records Management Section, Department of Justice (RMS-DOJ) requested for the purchase of various consumables for SHARP AR 6031N copier machine for the official use of the RMS - DOJ, to wit:

WHEREAS, the procurement for spare parts and consumables for various photocopying machines is included in the CY-2021 Annual Procurement Plan (APP) of the Department with Direct Contracting as the mode of procurement;

WHEREAS, a certificate of distributorship and guarantee to supply dated 17 March 2021 was issued by Sharp Corporation through its Asia Marketing Center General Manager Osamu Narita certifying that e-Copy Corporation (e-Copy) is the sole and exclusive distributor authorized to apply for eligibility and to bid on all "SHARP" multi-function digital copiers, including its accessories, consumables and spare parts in the Philippines;

WHEREAS, e-Copy Corporation submitted a quotation for the said consumable items for SHARP AR 6301 copier machine in the total amount of Four Thousand Eight Hundred Thirty-Three Pesos (₱ 4,833.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee RESOLVES, as it hereby resolve, to RECOMMEND the confirmation of resort to alternative mode of procurement of Direct Contracting, and further recommend the award of contract to E-Copy Corporation, as exclusive distributor of Sharp Corporation,
