
(Payments shall be made through Land bank's LDDAP-ADA/Bank Transfer facility. Bank Transfer fee shall be charged against the creditor's account.)

2. Price quotation must be valid for a period of thirty (30) calendar days from the date of submission of quotation;
3. Quoted prices must be inclusive of taxes and other charges of fees and shall not exceed the Approved Budget for the Contract (ABC);
4. Contract will be awarded to the lowest calculated and responsive bid (Meals, accommodation and function room) which complies with the minimum technical specifications and other terms and condition;
5. Any interlineations, erasures or overwriting shall be valid only if they are properly signed or initialed by the bidder or his/her duly authorized representative/s.
6. Bidders must submit copies of 2022 Mayor/Business Permit, 2021 Income/Business Tax Return, PhilGEPS Registration Number or Certification along with your quotation/proposal.

Please quote your price on the Price Quotation Form in the succeeding page, subject to the General Conditions indicated therein and submit your quotation duly signed by your representative to the BAC Secretariat in-charge of RFQ or thru the authorized canvasser of this Department not later than 15 November 2022.
