RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF ONE (1) TUBE TK-7109 TONER FOR KYOCERA TASKALFA 3010i COPIER THROUGH SECTION 50 (DIRECT CONTRACTING) OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. 9184

WHEREAS, included in the CY-2022 Annual Procurement Plan of the DOJ (Delegated to Region XI BAC) is the procurement of various consummables for photocopiers with an Approved Budget of the Contract of One Hundred Sixty-Three Thousand Four Hundred Pesos (P163,400.00);

WHEREAS, one (1) tube of TK-7109 toner for the Kyocera Taskalfa 3010i Copier, assigned in the Office of the Provincial Prosecutor of Davao del Sur with Property No. DJ-OE-XEROX-16-245 shall be procured pursuant to Section 50 (Direct Contracting) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the BAC-RPO XI, thru the BAC secretariat, invited Philcopy Corporation, the exclusive distributor in marketing and servicing Kyocera Document Solutions brand copiers, laser printers and multi-functional peripheral, software solutions, including related consumables and spare parts in the Philippines, per Sworn Certificate of Guarantee Exclusive Distributorship Agreement dated 04 March 2022 issued by Takuma KIMURA, President, Kyocera Document Solutions Asia Limited, to accomplish the Request for Quotation (RFQ) Form No. 2022-TONER-APR-002 dated 26 April 2022;

WHEREAS, the BAC received a price quotation for one (1) tube of TK-7109 toner for the Kyocera Taskalfa 3010i Copier from Philcopy Corporation;

WHEREAS, the BAC, upon careful evaluation and deliberation, found the proposal of Philcopy Corporation, along with its eligibility requirements, to be compliant with the specifications of the duly accomplished RFQ, and is declared as the single calculated and responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity (HOPE) or his/her duly authorized representative;

NOW THEREFORE, for and in consideration of the foregoing, we, the members of the BAC of the RPO XI, **HEREBY RESOLVED** to recommend for the approval of the HOPE that the contract for the procurement of one (1) tube of TK-7109 toner for the Kyocera Taskalfa 3010i Copier be awarded to **Philcopy Corporation**, the single calculated and responsive quotation, with a contract amount of Eight Thousand Five Hundred Pesos (₱ **8,500.00**).
