**RESOLUTION No. 2022- 09- 0024**

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO OHANA'S MEDICAL SUPPLIES TRADING FOR THE SUPPLY AND DELIVERY OF COVID-19 RESPONSE ITEMS FOR NPS- REGION 1**

**WHEREAS**, the Regional Prosecution Office 1, through the Bids and Awards Committee (BAC), intends to procure Covid-19 Response Items to comply with the minimum health standards for COVID-19 mitigation;

**WHEREAS**, the purchase of Covid-19 Response Items is included in the Annual Procurement Plan- Common Supplies and Equipment (APP- CSE) 2022;

**WHEREAS**, the subject procurement has an Approved Budget for the Contract (ABC) of Twenty-Seven Thousand Two Hundred Ninety-Eight and 80/100 pesos (P27, 298.80) and shall be undertaken in accordance with the provisions of Sec. 52.1(b) of the Revised Implementing Rules and Regulations of RA 9184;

**WHEREAS**, the Bids and Awards Committee (BAC) of the NPS-R1, thru its secretariat, posted the Request for Quotation (RFQ) for the purchase of Covid-19 Response Items in the PhilGEPS, DOJ Website and in a conspicuous place in the premises of the City of San Fernando, La Union continuously from August 22 to August 29, 2022;

**WHEREAS**, before the lapse of the deadline for submission of quotations, the BAC received three (3) quotations from three (3) different suppliers. Below are the names of the bidders with their respective proposals:

**WHEREAS**, based on the above result, the offer of Ohana's Medical Supplies Trading was declared as the 1<sup>st</sup> Lowest Calculated Bid (LCB);

**WHEREAS**, the BAC proceeded with the evaluation and validation of the proposal and other documents submitted by Ohana's Medical Supplies Trading. Accordingly, the BAC considered its bid to have complied with all the required legal, technical and financial requirements. Thus, the BAC recommended to declare the said bidder as responsive and eligible bidder;

**NOW, THEREFORE**, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby **RESOLVED** to recommend the award of contract for the supply and delivery of Covid-19 Response Items and the approval of the Purchase Order No. 2022-09-0021 in the amount of **Twenty-Five Thousand Sixty Pesos (P 25, 060.00)** in favor of Ohana's Medical Supplies Trading.
