RESOLUTION NO. 2022-02-0007

BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO WERB PRINTING AND GEN. MDSE FOR THE PURCHASE OF 100 PIECES T-SHIRT (25 SMALL, 25 MEDIUM, 15 LARGE, 15 XL, 20 XXL) PRINTED WITH DOJAC LOGO FOR DEPARTMENT OF JUSTICE ACTION CENTER REGION 1

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), requested quotations for the purchase of 100 pieces T-Shirt (25 Small, 25 Medium, 15 Large, 15 XL, 20 XXL) printed with DOJAC Logo with the Approved Budget for the Contract (ABC) of Eighteen Thousand Pesos (Php18,000.00);

WHEREAS, Ohana's Consumer Goods Trading's was declared the 2nd Lowest Calculated and Responsive Bidder;


WHEREAS, Metrovision Customized Printing & Gen. Mdse was declared the 3rd Lowest Calculated and Responsive Bidder;

Mdse to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of the contract;
