**RESOLUTION NO. 2022-04-0016**

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT  
TO JANPAC REALTY AND DEVELOPMENT  
FOR THE CONDUCT OF GENDER AND DEVELOPMENT TRAINING FOR  
PROSECUTORS AND STAFF (VENUE AND MEALS) ON MAY 19, 2022  
FOR NPS- REGION 1**

**WHEREAS**, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), posted the notice for the conduct of Gender and Development Training for Prosecutors and Staff (Venue and Meals) with the Approved Budget for the Contract (ABC) of Three Hundred Nineteen Thousand, Four Hundred Pesos (Php 319,400.00) on March 28, 2022 to April 4, 2022 in the PhilGEPS, DOJ Website and in a conspicuous place in the premises of the City of San Fernando, La Union;

**WHEREAS**, the BAC received three (3) quotations from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:

**WHEREAS**, as a result of bid opening, Kahuna Beach Resort and Spa has no bid due to its incapacity to accommodate 440 pax;

**WHEREAS**, Awesome Hotel Inc.'s offer was disqualified as the bid exceeds the ABC;

**WHEREAS**, JANPAC Reality and Development's offer was declared as the 1<sup>st</sup> LCB and responsive;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the 1<sup>st</sup> Lowest Calculated and Responsive Bidder, the BAC found the offer of JANPAC Reality and Development to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of contract;

**NOW, THEREFORE**, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity the award and approval of Purchase Order No. 2022-04-0014 in the amount of Three Hundred Nineteen Thousand Pesos (Php 319,000.00) for the Conduct of Gender and Development Training for Prosecutors and Staff (Venue and Meals) for NPS- Region 1 in favor of JANPAC Reality and Development.
