RESOLUTION NO. 2022-04-0015

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT
TO PANDAYAN BOOKSHOP INC.
FOR THE PURCHASE OF VARIOUS OFFICE SUPPLIES NOT AVAILABLE IN THE
PROCUREMENT SERVICE
FOR NPS- REGION 1**

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), posted the notice for the purchase of various office supplies not available in the Procurement Service with the Approved Budget for the Contract (ABC) of Four Hundred Sixty-Nine Thousand, Forty Pesos and 62/100 (Php 469,040.62) on March 28, 2022 to April 4, 2022 in the PhilGEPS, DOJ Website and in a conspicuous place in the premises of the City of San Fernando, La Union;

WHEREAS, the BAC received five (5) quotations from five (5) suppliers. Hereunder are the names of suppliers with their respective bids:

WHEREAS, as a result of bid opening, New Malayan Commercial's offer was non-responsive due to incomplete documentary requirements;

WHEREAS, Pandayan Bookshop Inc., Agua Visions Trading, Ohana's Consumer Goods Trading, and MSN Consumer Goods Trading's offers were declared as the 1st, 2nd, 3rd and 4th LCB respectively and responsive;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the 1st Lowest Calculated and Responsive Bidder, the BAC found the offer of Pandayan Bookshop Inc. to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of contract;

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity the award and approval of Purchase Order No. 2022-04-0013 in the amount of Three Hundred Thirty-Two Thousand, Three Hundred Thirty-One Pesos and 88/100 (Php332,331.88) for the purchase of Various Office Supplies Not Available in the Procurement Service for NPS- Region 1 in favor of Pandayan Bookshop Inc.
