RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PROJECTS UNLIMITED (PHIL.) INC. FOR THE DISMANTLING, TRANSFERRING, AND REINSTALLATION OF FIVE (5) SETS OF COMPACTOR CABINETS FROM THE DEPARTMENT OF JUSTICE COMPOUND IN MANILA TO THE OFFICES OF THE CITY PROSECUTORS OF CALOOCAN AND PARAÑAQUE

WHEREAS, there is a need to dismantle, transfer, and reinstall five (5) sets of compactor cabinets from the Department of Justice (DOJ) compound in Manila to the Offices of the City Prosecutors of Caloocan and Parañaque;

WHEREAS, the procurement of the said project is included in the approved CY-2022 Supplemental Annual Procurement Plan No. 2 (SAPP 2) under negotiated procurement with an allotted budget of One Hundred Fifty Thousand Pesos (₱ 150,000.00);

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project with an approved budget for the contract of One Hundred Fifty Thousand Pesos (₱ 150,000.00) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for four (4) calendar days starting 07 March 2022;

WHEREAS, in response to the said invitation, a prospective supplier submitted its quotation, *to wit*

WHEREAS, after review and evaluation, the Bids Awards Committee –Technical Working Group found Projects Unlimited (Phil.) Inc. to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Single Calculated and Responsive Quotation;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to an alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **PROJECTS UNLIMITED (PHIL.) INC.** for the dismantling, transferring, and installation of five (5) sets of compactor cabinets from the
