RESOLUTION NO. 2022-RATTFXI-BT/OSAEC

RECOMMENDING THE AWARD OF CONTRACT FOR THE LEASE OF VENUE WITH MEALS and ACCOMMODATION FOR THE BASIC TRAINING ON TIP AND OSAEC FOR DOJ-NPS XI SUPPORT STAFF ON 24-25 NOVEMBER 2022 THROUGH SECTION 53.10 (NEGOTIATED PROCUREMENT-LEASE OF REAL PROPERTY AND VENUE) OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, included in the CY-2022 Annual Procurement Plan is the Basic Training on TIP and OSAEC for DOJ-NPS XI Support Staff requiring the Lease of Venue with Meals and Accommodation, to be undertaken through Section 53.10 (under Negotiated Procurement-Lease of Real Property and Venue) of the Revised Implementing Rules and Regulations of Republic Act (R.A.) No. 9184;

WHEREAS, the procurement of Lease of Venue, including Meals and Accommodation, with an Approved Budget for the Contract (ABC) of **One Hundred Seventy-five Thousand Pesos (Php 175,000.00)**, shall be conducted on 24-25 November 2022, in Davao City;

WHEREAS, efforts were exerted to locate a government facility within Davao City which could comply with the requirements of the end-user, however, none was found;

WHEREAS, on 09 November to 14 November August 2022, the Regional Prosecution Office XI (RPO XI) BAC, thru its Secretariat, initiated the procurement activity by sending Request for Quotation (RFQ) No. 2022-RATTFXI-BT/TIP-OSAEC to at least three (3) lessors;

WHEREAS, prior to the deadline of submission of price quotations, the BAC Secretariat obtained four (4) replies, but only one quoted, with the following details:

WHEREAS, it appeared that the proposal of Eden Mountain Resort, Inc. is the most advantageous to the government in terms of price, amenities, space, location and site condition;


WHEREAS, after careful review and evaluation of the documentary, technical and financial requirements submitted by the bidder, The BAC declares Eden Mountain Resort, Inc. as the single calculated and responsive quotation;


WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the HOPE or his/her duly authorized representative;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the RPO XI BAC, **HEREBY RESOLVED** to recommend for the approval of the HOPE that the contract of Lease of Venue with Meals and Accommodations for the Basic Training on TIP and OSAEC for DOJ-NPS XI Support Staff on November 24-25, 2022 be awarded to **Eden Mountain Resort, Inc.**, the single calculated and responsive quotation, in the amount of **One Thousand Seventy Thousand Pesos only (Php 170,000.00)**.


This resolution is passed on 18 November 2022, at the Regional Prosecution Office XI, 2/F Hall of Justice Bldg., Candelaria Avenue, Ecoland, Davao City.


