RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE T and E ENTERPRISES FOR THE PURCHASE OF VARIOUS CONSUMABLES FOR PRINTERS

WHEREAS, there is a need for the purchase of various consumables for printers;

WHEREAS, the DOJ, NPS - Region IV posted its Invitation to Bid for the aforesaid purchase of Various Consumables for Printers in the PhilGEPS, DOJ Website, and in conspicuous place in the City Prosecutor's Office of San Pablo and Office of the Regional Prosecutor, Region IV Hallways continuously for seven (7) calendar days starting 14 June 2022;

WHEREAS, the purchase of the aforementioned goods is included in the Annual Procurement Plan (APP) for CY 2022 of the Department of Justice, with a total allotted budget of **One Million Four Hundred Thirty-Six Thousand Three Hundred Seventy-Seven Pesos (Php 1,436,377.00)**;

WHEREAS, in response to the invitation, two (2) prospective suppliers submitted their respective Bid in a Public Bidding; One (1) prospective supplier submitted bid in a public bidding through electronic files via email (*bacsecretariat04@gmail.com*); and the other one (1) prospective supplier personally submitted its bid in a public bidding at ORP, Regional Office, Region IV, Trece Martires Street, San Pablo City.

WHEREAS, during the Opening of Bid documents held on 04 July 2022, 02:00 p.m., the BAC Chairperson ordered the suspension of the proceedings due to technical reasons. In said opening of bid documents, the two prospective suppliers and observer from Laguna Guardians Brotherhood Incorporated (LGBI) were present. COA was notified but did not join the meeting. The following day, July 5, 2022, 02:00 p.m. the BAC committee resumed with the opening of bid documents which was attended by the two Prospective Suppliers, and observer from Police Hotline Movement Incorporated (PHMI). The COA was likewise notified and invited to join the resumption of the opening of bid documents. The opening of bid documents yielded the following result, to wit:

WHEREAS, the aforesaid bid was referred to the DOJ, ORP- Bids and Awards Committee – Technical Working Group (BAC-TWG) for evaluation and post-qualification, of the following findings;

WHEREAS, the DOJ BAC-TWG, after review and evaluation, finds that, **T and E ENTERPRISES** is legally, financially and technically capable to undertake the subject procurement;

NOW, THEREFORE, after thorough deliberation, the Bids and Awards Committee **RESOLVES**, as it hereby resolves to **RECOMMEND** the award of contract to **T and E ENTERPRISES** in the amount of **ONE MILLION TWO HUNDRED SEVENTY- SEVEN THOUSAND PESOS (Php 1,277,000.00)**, for the purchase of Various Consumables for Printers, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
