BAC RESOLUTION NO. 17-2022

RESOLUTION RECOMMENDING SHOPPING AS ALTERNATIVE METHOD OF PROCUREMENT OF OFFICE SUPPLIES/MATERIALS (ATTACHED PURCHASE)

WHEREAS, the Bids and Awards Committee of Regional Prosecution Office, Region 10, Cagayan de Oro City has agreed to issue recommendation to the Regional Prosecutor regarding the mode of procurement for the purchase of Office Supplies/Materials for the Prosecution Offices in Region 10 for (July to September 2022);

WHEREAS, upon examination of said purchase request and the supporting documents required for the procurement, the BAC Members find that the purchase was in accordance with the provision of IRR Rule XVI Section 52.1 (b) of RA – No. 9184 (6th Edition 2012);

1. The regular office supplies are not available in PS-DBM per attached certification from PS-DBM.
2. The total estimated cost of the said procurement does not exceed to Php. 1,000,000.00 as stated in the threshold of revised IRR of RA 9184 effective October 28, 2016.
3. Goods to be procured are included in the Region Annual Procurement Plan (APP) 2022 charged against MOOE;
4. The prices offered by the supplier are most advantageous to the government.
5. The price quotation amounting to P 41,191.00 of MGM Consumer Goods Trading is found to be the lowest among the three suppliers who quoted.

NOW THEREFORE, on unanimous accord of all members present;


BE IT RESOLVED, AS IT HEREBY RESOLVED that the BAC recommends to the Regional Prosecutor that shopping be applied as the mode of procurement for the above mentioned procurements;


