RECOMMENDING THE AWARD OF CONTRACT VIA NEGOTIATED PROCUREMENT TO MINKAY RESORT & CATERING SERVICES FOR THE PROCUREMENT OF 1 MEAL-LUNCH AND 2 SNACKS A.M & P.M. (200 PAX) FOR THE REGIONAL TEAM BUILDING WORKSHOP ON JUNE 10, 2022

WHEREAS, the RPO 10 BAC prepared the Term of Reference for the procurement of 1 meal-lunch and 2 snacks AM & PM on June 10, 2022 with an Approved Budget for the Contract (ABC) of P160,000.00

WHEREAS, on May 24, 2022 the RPO-10 Bids and Awards Committee (BAC) posted/published the Request for Quotation for the said procurement project. The RPO-10 BAC also invited the following Suppliers to submit their respective quotations/proposals : 1) Minkay Resort & Catering Services 2) Kinason Beach Resort 3) Moonbay Resort;

WHEREAS, per evaluation, the proposal of Minkay Resort & Catering Services found to be compliant with the requirements, and its price quotation amounting to P 160,000.00 is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated responsive bid.

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of Contract to the Head of the Procuring Entity of his/her duly authorized representative.

NOW THEREFORE, for and in consideration of the foregoing, WE, the members of RPO-10 BAC, hereby recommend to Regional Prosecutor Merlynn Barola-Uy, Head of the Procuring Entity pursuant to Department Order No. 783 dated December 06, 2017 the following:

- (1) AWARD OF CONTRACT via Small Value Procurement to Minkay Resort & Catering Services, for the Procurement of 1 meal-lunch and 2 snacks AM & PM in the amount P 160,000.00 inclusive of appropriate taxes and fees.
- (2) GRANT OF AUTHORIZATION for the BAC Chairperson to sign the corresponding Notice of Award and Notice to Proceed to implement this resolution.
