RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE BRAIN COMPUTER CORPORATION FOR THE RENTAL OF SOUND SYSTEM, LIGHTING EFFECTS AND LED WALL FOR THE YEAR-END ASSESSMENT OF THE DEPARTMENT OF JUSTICE ON 16 DECEMBER 2022

WHEREAS, there is a need for the rental of sound system, lighting effects, and LED wall for the Year-End Assessment of the Department of Justice (DOJ) on 16 December 2022;

WHEREAS, the procurement of the said year-end assessment is included in the CY-2022 Annual Procurement Plan (APP) under negotiated procurement with a total allotted budget of One Million One Hundred Seventy Thousand Pesos (₱ 1,170,000.00);

WHEREAS, a Request for Quotation (RFQ) for the aforementioned project with an approved budget for the contract of Ninety Thousand Pesos (₱ 90,000.00) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department on 24 November 2022;

WHEREAS, in response to the said RFQ, only one (1) supplier submitted its quotation, *to wit*:

WHEREAS, after review and evaluation, the Bids and Awards Committee – Technical Working Group (BAC-TWG), found The Brain Computer Corporation to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Single Calculated and Responsive Quotation;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to an alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **THE BRAIN COMPUTER CORPORATION** for the rental of sound system, lighting effects, and LED wall for the

Year-End Assessment of the Department of Justice on 16 December 2022, in the amount of **EIGHTY-SIX THOUSAND TWO HUNDRED PESOS (₱ 86,200.00)**, following the procedures prescribed in R.A. No. 9184 and its Implementing Rules and Regulations.
