RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO NEONOTIONS EVENTS MANAGEMENT FOR THE VIDEO AND POSTER PRODUCTION OF HUMAN TRAFFICKING AWARENESS CAMPAIGN OF THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING

WHEREAS, there is a need to produce a video and poster for the Human Trafficking Awareness Campaign of the Inter-Agency Council Against Trafficking (IACAT);

WHEREAS, the procurement of the said video and poster production is included in the approved CY-2022 Annual Procurement Plan (APP) under negotiated procurement with an allotted budget of Five Hundred Thousand Pesos (₱ 500,000.00);

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project with an approved budget for the contract of Four Hundred Ninety-Seven Thousand Four Hundred Fifteen Pesos (₱ 497,415.00) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously from 15 March 2022 to 21 March 2022;
