“RESOLUTION RECOMMENDING FOR THE APROVAL OF AWARD OF WINNING BID OF PROCUREMENT OF 12 INCHES AND 7 INCHES ACRYLIC PLAQUES WITH CITATION TO BE USED BY REGIONAL PROSECUTION OFFICE VIII FOR ITS 2-DAY REGIONAL YEAR-END ASSESSMENT AND STRATEGIC PLANNING AND GAD TRAINING PROGRAM ON NOVEMBER 24-25, 2022”

WHEREAS, there is an approved Purchase Request (PR) dated October 27, 2022, with an Approved Budget for the Contract (ABC) of EIGHT THOUSAND SIX HUNDRED PESOS (P8,600.00) only;

WHEREAS, this activity is included in the 2022 Annual Procurement Plan (APP) of NPS R-VIII, and such procurement is approved by the BAC dated November 3, 2022 through Alternative Method of Procurement under Negotiated - Small Value Procurement in accordance with Section 53.9 of the Revised IRR of RA 9184;

WHEREAS, the BAC, thru its Secretariat has undertaken the following activities:

- 1. Posted request for the Price Quotation on November 4, 2022, at the Philippine Government Electronic Procurement System (Philgeps), Bulwagan ng Katarungan Bulletin Board, Tacloban City, official DOJ website page and official RPO-VIII Procurement Facebook page and set submission for the Price Quotation on or before November 7, 2022;**
- 2. Requested quotations from the Three (3) suppliers of known qualifications, such as:**

2.1 TACLOBAN MABUHAY GLASS SUPPLY, P. Burgos St., Brgy. 37, Tacloban City, with Platinum Philgeps Membership valid

2.2 HANZ GRAPHICS AND DIGITAL IMAGING CENTER, J. Romualdez St., Brgy. 14, Tacloban City, with Platinum Philgeps Registration, Mayor's Business Permit Nos. 2022 01243/1244/01245/, DTI Certificate No. 1030592; and Tax Clearance Certificate No. 166-548-3740-000;

2.3 CUA'S TROPHIES ATHLETIC SUPPLY AND ENTERPRISES, Cua's Bldg., 182 Avenida Veteranos St., Brgy. 24, Tacloban City, with Platinum Philgeps Membership, Mayor's Permit No. 2022 02125, DTI Certificate No. 2917215; and Tax Clearance Certificate No. 151-117-514-000;

3. Received the three (3) price quotations from the aforementioned suppliers on November 7, 2022;

WHEREAS, on November 7, 2022, BAC conducted a pre-examination of bids to determine bidders' compliance with the technical component requirements;

WHEREAS, among the three (3) bidders, Tacloban Mabuhay Glass Supply was determined ineligible for failure to comply with Section 23 Rule VIII of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, particularly on the tax clearance requirement;

WHEREAS, BAC proceeded with the opening and evaluation of the financial component of the bids for the two (2) remaining bidders;

WHEREAS, BAC evaluated the two (2) remaining qualified bidders and consolidated their quotations in the Abstract of Canvass;

WHEREAS, the qualified bidders quoted the same amount; that however, upon evaluation, Hanz Graphics and Digital Imaging Center is found superior in terms of product quality and workmanship than Cua's Trophies Athletic Supply and Enterprises;

NOW, THEREFORE, for and in consideration of the foregoing, it is hereby RECOMMENDED to the Head of Procuring Entity (HOPE) that the procurement of 2 pieces 12 inches plaques and 5 pieces 7 inches plaques with citation for the two (2) - day Regional Year-End Assessment and Strategic Planning and GAD Training Program of the NPS R-VIII on November 24-25, 2022, be awarded to "HANZ GRAPHICS AND DIGITAL IMAGING CENTER," having satisfied the service
