BAC Resolution No. 2022-20

**RECOMMENDING THE AWARD OF CONTRACT TO VILLA BLANCA HOTEL FOR
THE PROCUREMENT OF MEALS AND ROOM ACCOMMODATIONS DURING
THE GENDER AND DEVELOPMENT (GAD) SEMINAR-WORKSHOP TO BE HELD
ON OCTOBER 13-14, 2022**

WHEREAS, the **DEPARTMENT OF JUSTICE-NATIONAL PROSECUTION SERVICE (DOJ-NPS) Region 02** will conduct a two-day **Gender and Development (GAD) Seminar-Workshop** on October 13-14, 2022 in Tuguegarao City, Cagayan to be participated by forty-five (45) support staff selected from the region;

WHEREAS, aside from meals and snacks, majority of the participants will also be provided room accommodations for the entire duration of the activity;

WHEREAS, an Approved Budget of Contract (ABC) of **Eighty Thousand Five Hundred Fifty Pesos (Php 80,550.00)** has been allotted for the procurement of meals and room accommodations and shall be undertaken through Section 53.10 (Lease of Venue), in relation to Item (9).(c).(ii) of Annex "H", under the Negotiated Procurement method of 2016 Revised IRR of R.A. 9184.;

WHEREAS, Section 54.2 of the 2016 Revised IRR of R.A 9184 excludes the procurement for the lease of venue in the posting requirement of the Request for Quotation (RFQ) at the PhilGEPS website, website of the procuring entity, and at any conspicuous place in the premises of the procuring entity;

WHEREAS, in lieu of the posting requirement, Government Procurement Policy Board (GPPB) Resolution No. 08-2009 requires the RFQ to be sent to at least three (3) lessors of known qualifications, thus the Committee, through its End-user, disseminated the RFQ to the different reputable establishments and hotels in Tuguegarao City;

WHEREAS, after due evaluation and assessment, the Committee, with the assistance of its technical and end-user unit, established the following, to wit:

1. Based on the foregoing Abstract, the quotations of **Pulsar Hotel Premier Suites, Las Palmas, and GO Plus Hotel** exceeded the Approved Budget of Contract (ABC) and thus are disqualified from the bidding, leaving **Villa Blanca Hotel** as the sole remaining bidder;
2. The Committee determined that the bid of **Villa Blanca Hotel** in the amount of **Seventy Nine Thousand Fifty Pesos (Php 79,050.00)** to be below the ABC and is compliant with the specifications prescribed by the Committee;
3. As such, the Committee finds the bid of **Villa Blanca Hotel** for the procurement of meals and room accommodations for the

participants, as the lowest calculated and responsive bid and is most advantageous to the government.

NOW THEREFORE, after thorough deliberation, the Committee **RESOLVES**, as it hereby resolves, to **RECOMMEND** the awarding of the contract to **Villa Blanca Hotel** for the procurement of meals and room accommodations for the participants of the Gender and Development (GAD) Seminar-Workshop on October 13-14, 2022 in the amount of **Seventy Nine Thousand Fifty Pesos (Php 79,050.00)**;

RESOLVED FURTHER, that Notices of Award and to Proceed be forthwith issued to **Villa Blanca Hotel** upon the approval of these findings and recommendations by the Head of Procuring Entity, following the procedures prescribed in R.A. No 9184 and its 2016 Revised Implementing Rules and Regulations.
