RECOMMENDING AWARD OF CONTRACT FOR THE INSTALLATION OF MANUAL TRANSFER SWITCH WIRINGS AND COVER FRAME/HOUSING OF DOJ ISSUED FUJIHAMA DIESEL GENERATOR IN OCP LIGAO (LABOR) UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF THE REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of Eleven Thousand Seven Hundred Pesos Only (P11,700.00) for the Installation of Manual Transfer Switch Wirings and Cover Frame/Housing of DOJ Issued Fujihama Diesel Generator in OCP Ligao (Labor);

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, on 23 September 2022, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers, viz;

1. Rei-tech Construction & Supply;
2. 3 Summits Construction & General Merchandise;
3. MTJ Construction & Supply.

WHEREAS, the submission and opening of bids was scheduled on 29 September 2022;

WHEREAS, on 29 September 2022 prior to the deadline of submission of bid, out of three (3) request for quotations only two (2) quotations from suppliers were obtained by the BAC Secretariat, attested by accomplished RFQs;


WHEREAS, per evaluation, bid of 3 Summits Construction & General Merchandise is found to be compliant with the specifications and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;


