RECOMMENDING AWARD OF CONTRACT FOR THE VENUE AND MEALS FOR THE YEAR-END ASSESSMENT OF NPS REGION V ON DECEMBER 1, 2022 UNDER NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY OR VENUE) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF THE REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of Thirty-Nine Thousand Six Hundred Pesos Only (Php39,600.00) for the Venue and Meals for the Year-end Assessment of NPS Region V on December 1, 2022;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ Website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, on 28 October 2022, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers, viz;

1. A and A Bed and Breakfast Inn Corp.;
2. Bicol Food Delights Catering Services
3. A.V.P. Catering Services;
4. Ninong's Hotel;
5. Hotel Ifiigo.

WHEREAS, the submission and opening of bids was scheduled on 03 November 2022;

WHEREAS, request for quotations from suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

5. Hotel Ifiigo		Php57,750.00	Ineligible, bid offer is above the Approved Budget for the Contract.




