**WHEREAS**, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ Website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

**WHEREAS**, on 28 October 2022, the RPO V- Bids and Awards Committee Secretariat thru the DOJ-IACAT V Staff sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers, viz;

3. Asog County Hotel		Php96,000.00	Eligible, compliant with the specifications and documentary requirements.


**WHEREAS**, per evaluation, bid of Asog County Hotel is found to be compliant with the specifications and eligibility requirements;
