RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO FRANCISCO'S REFRESHMENT AS THE CATERING SERVICE PROVIDER OF THE FOOD FOR THE GENDER AND DEVELOPMENT SEMINAR AND YEAR-END RECOGNITION ACTIVITY ON OCTOBER 27 AND 28, 2022

WHEREAS, there is a need for a food catering service for the meals for the **GENDER AND DEVELOPMENT SEMINAR AND YEAR-END RECOGNITION ACTIVITY** on October 27 and 28, 2022 with an Approved Budget for the Contract (ABC) of **Three Hundred Thousand Pesos (Php 300,000.00)**;

WHEREAS, procurement of the aforementioned goods and services are included in the Annual Procurement Plan (APP) for CY 2022 of the Department Proper;

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project was posted in the PhilGEPS websites and in conspicuous places in the Iloilo City Hall and Iloilo Provincial Capitol;

WHEREAS, in response to the said RFQ, the following suppliers submitted quotations before the deadline of September 26, 2022; 2:00 P.M:

WHEREAS, the End-user of the Program, Ms. Melissa Joy A. Ohao, Administrative Officer V, Office of the Regional Prosecutor VI together with the Technical Working Group, submitted their evaluation of the offers of the following prospective suppliers pursuant to the criteria (50% Price and 50% Quality of Food), *to wit*:

Regatta Hotel, Inc.	TOTAL: 85%

WHEREAS, after review and evaluation, the Bids and Awards Committee – Technical Working Group found Francisco's Refreshment to be legally, financially and technically capable to undertake the subject procurement;

NOW THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it is hereby resolves to **RECOMMEND** the approval of an alternative mode of procurement, Negotiated Procurement Sec 53.9 of the IRR - Small Value Procurement and to further recommend the award of contract to

Francisco's Refreshment for the catering services for the participants in the October 27 and 28, 2022 - Gender and Development Seminar and Year-End Recognition Activity, in the amount of Two Hundred Twenty-Six Thousand Pesos (Php 226,000.00) following the procedures prescribed in R.A. 9184 and its Revised Implementing Rules and Regulations.




