**BAC RESOLUTION NO. 2022-08-038**

**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS OFFICE SUPPLIES (NOT AVAILABLE IN DBM-PS) FOR NPS REGION V UNDER SHOPPING (SECTION 52.1B) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.**

**WHEREAS**, the Department approved the budget of Three Hundred Seventy-Seven Thousand Two Hundred Sixty-Nine Pesos & 89/100 Only (P 377,269.89) for the Supply and Delivery of Various Office Supplies (Not Available in DBM-PS) for NPS Region V;

**WHEREAS**, the BAC declared first Failure of Bidding during its Opening of Bids on 08 August 2022 due to no eligible bidders, and recommended the conduct of Re-bidding with Re-posting under BAC Resolution 2022-08-035;

**WHEREAS**, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat re-posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ NPS Region V Facebook Page, and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

**WHEREAS**, the schedule for the submission and opening of bids for re-bidding is on 17 August 2022;

**WHEREAS**, request for quotations from contractors/suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

4. New Silahis Office Supplies Trading		P 324,636.70	- INELIGIBLE, due to incomplete entry in the RFQ form.


