RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF MEALS, ACCOMMODATION AND FUNCTION HALL FOR THE ETHICAL LEADERSHIP TRAINING (CSC TRAINING) OF NPS REGION V UNDER SECTION 53.10 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of Eighty Thousand Three Hundred Fifty Pesos (Php80,350.00) for the Procurement of Meals, Accommodation and Function Hall for the Ethical Leadership Training (CSC Training) of NPS Region V on August 23-24, 2022;

WHEREAS, the Regional Prosecution Office V Bids and Awards Committee (BAC) Secretariat sent the Request for Quotation (RFQ) to the following supplier;

1. The Marison Hotel/Legazpi Mei Li Inc.;
2. Patio De San Jose Resort & Convention Center Inc.;
3. The Oriental Hospitality and Management Services Inc.;
4. Hotel St. Ellis;
5. Conrado Cecilia Holdings Inc.

WHEREAS, the submission and opening of bids was scheduled on 27 July 2022;

WHEREAS, request for quotation from suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

4. Hotel St. Ellis		Php79,890.00	Eligible, compliant with the specifications and eligibility requirements.
5. Conrado Cecilia Holdings Inc.		Php76,860.00	Ineligible, non-compliant with the eligibility requirements specifically no submitted Income Tax Return.

WHEREAS, upon careful review and evaluation of the documentary requirements submitted by the Bidders, the BAC determined that Hotel St. Ellis is eligible, compliant with all the specifications and eligibility requirements of the project;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his duly authorized representative;


